French Couple Seeks More Information About Fallen Sanford Soldier

Damien Le Youdec knows quite a bit about Paul Emile Duquette, a young soldier from Sanford who died in France in 1944, just 10 days after D-Day. He's hoping someone in the community can help him learn more.

Le Youdec and his wife
Aurélia, like a lot of people in
their part of Normandy, France,
wanted to honor American
soldiers who helped free their
country from Nazi occupation
nearly 80 years ago. They chose
to place flowers on Duquette's
grave at the Normandy American
Cemetery in Colleville-sur-Mer
every year, knowing that his family would not be able to do so.

Their research turned up some facts about Duquette's life. He was born in San-

ford on July 15, 1924, the only child of Theodore and Helen Bolduc Duquette. He enlisted on July 1, 1942, in Portland and joined the 8th Infantry Regiment of the 4th Infantry Division. He was only 19 when his barge landed on Utah Beach on June 6, 1944, D-Day. It was part of the first wave landing on the beach that day.

He survived the landing, when 197 soldiers in his division were killed and 60 reported missing. He and others in his unit traveled for 10 days to Montebourg, about 12 miles northwest of Utah Beach. There they entered fierce battles with Nazi occupiers and there, on June 16, Duquette was killed. Back home

in Sanford and nine days later, his father Theodore died suddenly of a ruptured aneurysm.

His mother buried her husband without knowing she had also lost her only child. "We can easily imagine the heartbreak for this mother when she learned the sad news one month after the death of her husband," Damien Le Youdec wrote. Helen outlived her husband and son by 50 years and is buried next to her husband at St. Ignatius Cemetery.

Le Youdec travels around his country sharing the story of France's liberation at elementary schools, high schools and colleges. He would like to learn more about Duquette, possibly from distant family members still in this area, to fill out his story with more pictures and perhaps military items.

City Council Meeting Summary May 21

The City Council met Tuesday May 21, 2024, for its regular meeting. All members were in attendance.

Mayor's Report/City Council Sub-Committee Reports

Mayor Becky Brink began the meeting with a brief history of Memorial Day. She followed this by expressing gratitude for the work that has been done by the Homeless Task Force.

Reporting for the Hazardous Jeff Roble
Waste Sub-committee, Councilor Robert
Stackpole said
that a household hazardous
waste cleanup day will be held on June 30
from 9 am to noon.

City Manager's Report

Sanford has received two grants from the Environmental Protection Agency. A \$500,000 assessment grant is to be used in the historic millyard for assessing environmental sites in the area and preparing four sites for cleanup. A \$5,000,000 cleanup grant will be used at the International Woolen Mill boiler house on Pioneer Ave. The cleanup will remove hazardous materials from the boiler house, such as volatile organic compounds, inorganic contaminants, heavy metals, polycyclic aromatic compounds, and light nonaqueous phase liquid.

A PBS documentary is in the works which centers around the arrival of asylum seekers in Maine with Sanford being a specific focal point as a city and community that organized a regional response.

May 5, 2023, saw the unanticipated arrival of asylum seekers to Sanford. The suc-

cess in establishing an organized response to the event has been studied, with the city's actions being adopted by Community Action Corporations across the state "as a case of best practices to adopt if experienced in another new area within Maine." Maine Public Brodcasting has also interviewed city staff about the event over the past year.

Although Sanford has reached its capacity to address the large influx of people, it continues to actively work towards integration of the new Mainer population into our region.

New educational material about the November Fire Station Referendum will be showcased at the June 4 City Council meeting. The materials will include educational slogans, informational flyers, updates to Informational videos, an ad campaign and site renderings for a future unveiling ceremony. A "cup of coffee campaign," which will measure the building costs for the new fire stations, and the possibility of minute-long informational videos to be shown at Smitty's Cinema are other options

being considered.

The Southern Maine Agency on Aging has signed a new lease for the Anderson Learning Center. The SMAA will offer adult day programming, along with Meals on Wheels, Medicare counseling, case management and support group services.

Homelessness Update

The Homeless Task Force is currently working on changes in Sanford's unhoused population stemming from the warming weather, such as individuals moving into encampments and becoming increasingly visible. To address the issue, Sanford Police have deployed officers on bikes and on foot to build trust between officers and unhoused individuals. The hope is to encourage unhoused individuals to accept assistance services available to them.

Notice has been given to the inhabitants concerning the impending closing of the Heritage Crossing encampment before June 15. According to City Manager Buck, "coordinated entry, case management, and housing navigation have all been extended to the individuals currently occupying this unhealthy and unsafe environment, with placements to date being limited to those individuals who are willing to take services."

Further actions to be taken regarding the encampment have been found to be in compliance with federal standards, specifically "19 Strategies for Communities to Address Encampments Humanely and Effectively" which was released by the U.S. Interagency Council on Homelessness. The Action Plan will be implemented in two weeks' time.

Coordination between multiple agencies assisting the unhoused community has seen significant results according to Buck, with time and resources being saved and agencies making the best use of existing resources.

Buck met with Maine State Housing representatives to discuss how available funds can benefit the City of Sanford. The city's current shelter system did not receive the funds it needs from the state, necessitating creative means to cover the current 1-million-dollar shortfall. Funding for street outreach workers has also been identified as a necessity.

An agreement with the York County Shelter Program to access emergency shelter space at a reduced cost, along with providing necessary ancillary service of meals and case management, will be coming before the City Council soon.

A request was made by Mayor Becky Brink for residents wishing to help Sanford's unhoused population to refrain from distributing food and clothing to individuals. The worry is that such actions will discourage unhoused individuals from accepting housing assistance. Citizens wishing to help can assist with distributing resources through the proper channels.

Communications/Presentations

Following the retirement of Lt. Steve Ouellette from the Sanford Fire Department, Firefighter/Paramedic Jeff Roble has been promoted to the rank of Lieutenant Paramedic.

New Business

Personnel in the Building and Codes Department and Municipal Constables were reappointed for the coming year.

The Council authorized the acceptance of grants.

The Council accepted an engineering proposal for inspection and repair to the Goodall Dam and an architect's proposal for work at Carpentier Park.

City Manager Buck has been chosen to represent Sanford on the Maine Municipal Association Legislative Policy Committee from July 2024 through June 2026. Mayor Brink has been appointed as his alternate if needed.

The Council approved the appointees to Sanford's Comprehensive Plan Steering Committee. Appointees that were previously removed from the committee because of a desire to limit participation to one person per household were restored and the disqualifier was lifted.

Council Member Comments

Councilors had a lengthy debate as to whether it was appropriate to fly the Pride Flag at City Hall during Pride Month. It was approved with Councilor Jonathan Martell voting against it citing religious reasons.

New Businesses and Development Come to Sanford

At the City Council's meeting on May 21, Keith McBride and Mary Hastings of the Sanford Regional Economic Growth Council highlighted some of the recent and future business to come to Sanford, including:

- Downhill Bagel on Main Street, Springvale
- Knots & Bolts, a craft store, in the former Bergeron's Shoe store
- Dayton Trailer Sales on Route 4
- Sebago Technics on Daigle Lane
- Guerrero Maya, a Mexican Restaurant, will be opening at the location of the old Backstreet Grill on School Street.

Recent land purchases at Cyro Drive and Eagle Drive by the Industrial Development Cooperation will be turned into "future development lots specifically targeted towards information technology and biopharmaceutical research company development," according to City Manager Steve Buck. McBride said Sanford is very well positioned to attract industrial development, as there is no other available land zoned for that purpose in Southern Maine.

Compliant with the National Environmental Policy Act, York County Community
College has provided findings showing that the establishment of a proposed Welding
Training Facility at 60 Community Dr. would have no impact on the environment.
The training facility, which will derive its building funds from the Economic Development Initiative and the Maine Industrial Alliance, will be tasked with training
Mainers to work in Maine's defense and civilian industries.

Emergency responders contain hazmat situation on Main Street: On May 16, the Sanford Fire Department and the York County Emergency Management Agency responded to a report about a possible ammonia leak at Arctic Glacier, a manufacturer of ice at 1913 Main St., after an odor was detected. Since ammonia releases a visible vapor, a person inside the building was able to share a video of the leak with responders so fire crews in full hazmat suits could quickly identify the location, seal the leak and shut down the equipment. No injuries were reported.

Shaw Field vandalism may lead to restricted

access: Despite heightened security measures, Shaw Field has recently experienced an increase in vandalism and misuse of the property and infrastructure. The facility is private property. Volunteers with the Sanford-Springvale Soccer Association (SSSA), a private non-profit organization, carry out the management and operation of the field. SSSA hopes to avoid restricting access to the facility; however, such thoughtless acts come at a real cost to the organization. Anyone who sees any suspicious activity or incidents at the field is asked to contact the Police Department.

Sheriff's Office warns of another scam: According to the York County Sheriff's Office (YCSO), several businesses and community members have received calls from someone claiming to be a Central Maine Power representative. In this scam, the caller tells the potential victim that their power will be shut off in 45 minutes due to non-payment of the bill. The caller then directs them to call 888-206-5307 to resolve the issue. This phone number, which connects to an automated phone system that identifies as CMP, eventually leads to someone who advises the person to go to Walmart and complete several Western Union transactions to pay the bill. The YCSO warns that CMP will never require a customer to pay a bill this way. Always locate the phone number or other contact information on your monthly statement.

Do I Need a Permit to Use My Fire Pit?

The short answer to whether fires in fire pits require a burn permit is "maybe." Maine residents and visitors need to be aware of a new law passed by the state in 2023 regarding recreational fires, including the use of fire pits, outdoor fireplaces and campfires for cooking, personal warmth, light, ceremonial or aesthetic purposes.

If you want to have an open fire of three feet or more in diameter on your property, or with flames at least three feet high, you need a burn permit. The permits are free and there are two ways to get one: in person at either of the Sanford fire stations, or online from the state here. http://www.maineburnpermit.com or http:// www.wardensreport.com.

Permits are only issued when the fire danger is rated "low" or "moderate." The daily fire danger is updated by 9 am each day at this website. https://mainefireweather.org/. When the fire danger is rated at "high" or above, the Maine Forest Service and National Weather Service will declare a Red Flag Warning, and no burn permits will be issued that day.

A permit is not required for recreational fires less than three feet in diameter, with flames less than three feet high. Most free-standing metal fire pits like the kind you can purchase at our local stores would not require a permit as long as you keep the flame height under three feet. However, it is important to check the fire danger page before starting any fire, because if a Red Flag Warning has been declared, fires of any size are not allowed, including charcoal grills. One exception to this rule is for a campground that is licensed and has an approved fire safety plan in place prior to the Red Flag Warning; then small recreational campfires are allowed.

Things to keep in mind:

- If your fire requires a burn permit, you need a new one each day you want to burn.
- Fires must be contained within a metal, masonry, or stone fireplace, pit or ring.
- Burning brush is not considered a recreational use; these fires always require a permit.
- The Sanford Fire Department responds to more than 4,000 calls a year and there will be times when no one is available at the station to help you with a permit. The online system is always available.
- Paper or cardboard may be burned as kindling only. Burning trash is illegal in Maine.
- If you are camping or recreating on someone else's property, you need permission from the landowner, who will need to get the burn permit before you kindle a fire or use a grill burning charcoal or wood.
- Gas grills do not require a permit and may be used even if a Red Flag Warning has been issued.
- Make sure to keep outdoor fire pits, charcoal grills and fireplaces at least 10 feet away from your home or anything else that might burn.

Accessible Garden Beds Coming to Community Garden

Thanks to the generosity of a local bank, the Mousam Way Land Trust this year is building something new at the Sanford Community Garden – accessible beds that allow gardeners to tend plants while seated in wheelchairs.

A Kennebunk Savings Bank grant has enabled the trust to construct a 20 by 50-foot deck that will eventually house six 4 by 12-foot beds at the McKeon Reserve. The hope is to have the beds ready by late summer. Appropriate tools, watering equipment and ramps will be available.

The latest improvements cap a six-year effort to develop a community garden at the reserve, off Blanchard Road in Springvale. In 2018, Land Trust directors endorsed the concept to plan and build a multi-faceted ecology center at the then newly acquired reserve. The David and Linda Pence Community Ecology Center was thus established, honoring the folks who helped make the reserve possible.

Despite some mishaps – in the wet spring of 2019, a truck delivering gravel to the garden slid off the soaked road, for example – the garden did get built. Within three years, it had doubled in size to 52 raised beds; 14 small kids' beds were also added for some of the gardeners' kids and grandkids. The current 66 raised beds, surrounded by an 8-foot-tall steel deer fence with 5-foot-wide gates, a tool shed, produce wash station, and picnic area under a shade-giving grape arbor, are now offered to local gardeners who may not have the space to have their own little garden.

Plans for the future include a greenhouse that will support propagation, self-guided

nature trails, assisted migration projects, the Master Gardener Volunteer Kids Can Grow program and the community garden. A botanical nursery will temporarily store and acclimate greenhouse plantings in support of the trust's various nature trails and other projects. An accessible outdoor restroom and garden tool shed have both been built with help from the Lowe's Heroes Project.

The Environmental Center – currently an old barn – will be the hub for holding community and group meetings. It includes an activity area for making bird and bat nesting boxes, informational trail placards,

and other eco-oriented projects.

And for the third year, the community garden is hosting the University of Maine Extension's Kids Can Grow program – a Master Gardener instructional and gardening-learning summer school – with support from Eldredge Lumber and Coast of Maine soil.




