Steady Stream of Voters Cast Ballots Early

Thousands of Sanford residents decided to vote early or absentee in this year's presidential election, beating the expected crowds on Tuesday at the high school.

City Clerk Sue Cote said that as of Wednesday evening, 5,144 of the city's 16,558 registered voters had either asked for an absentee ballot or come into City Hall to vote. All but 780 of the requested absentee ballots had been returned.

"We've had over 100 people each day" since Oct. 7, when her office started keeping extended hours to enable voters to pick up ballots or vote, Cote said. This could rival the 2020 presidential election, when 43 percent of Sanford voters skipped going to the polls, up from less than 30 percent in 2016.

While voters had the covid pandemic in mind four years ago, this year many may be worried about long lines at the single consolidated polling place. Cote said she expects the wait on Tuesday will be shorter than many people are expecting. There will be 100 voting booths and 10 ballot boxes set up in the gym. Close to 100 people, including city staff and residents who volunteered, will be working that day.

"There's going to be good traffic flow in there," she said. Parking should not be a problem as high school and Regional Technical Center students will be learning remotely that day.

The poll will be open from 7 am to 8 pm on Tuesday. Under state law, residents who are not yet registered may do so just before voting. The last chance to vote early or get an absentee ballot, however, was Thursday.

Lannigan Released on Bail, No Plea Entered



State Rep. Lucas Lanigan has been released on bail following his arraignment on a charge of domestic violence aggravated assault, a Class B felony that carries a penalty of up to 10 years imprisonment and a \$20,000 fine. His next court date will be in March.

Lanigan turned himself in to authorities on Monday, Oct. 28. At the arraignment hearing on Wednesday, District Court Judge John Lucy did not ask for a plea. The prosecution, led by Assistant District Attorney Linda Holdsworth-Donovan, had requested \$10,000 cash bail based on the gravity of the charge, while defense attorney William Bly of the


Maine Criminal Defense Group requested \$1,000 bail.

The victim made an emotional plea to have the charges dismissed, saying that she was angry, inebriated and attempting to harm herself, and that Lanigan was trying to stop her.



Judge Lucy noted that it is not uncommon for victims in domestic violence cases to be upset and

Russian-American Virtuosos in Concert

Classical music lovers will have an opportunity to hear two world-class musicians in concert at 3 pm on Sunday, Nov. 10, at the Sanford-Springvale Historical Museum, 505 Main St. Sergey Antonov and Ilya Kazantsev will perform music for cello and piano. Their program will feature compositions by Amy Beach, Frederic Chopin, Gregor Piatigorsky and Richard Strauss. In addition, the duo will perform two pieces by Dr. Morton Gold, distinguished local musician and composer.

These two virtuosos have performed around the world in some of the greatest concert halls, including Moscow's Rachmaninoff Hall and Saint Petersburg's Philharmonic Recital Hall. Both were child prodigies, having entered Tchaikovsky State Conservatory in Moscow before the age of 10.

Hailed as "a brilliant cellist" by the legendary Mstislav Rostropovich, Sergey Antonov went on to prove his mentor's proclamation when he became one of the youngest cellists ever awarded the gold medal at the world's premier musical contest, the quadrennial International Tchaikovsky Competition.

Pianist Ilya Kazantsev, praised by The Washington Post as "virtually flawless," has performed as a recitalist and a soloist with orchestras in Russia, Canada, Europe, and the United States. His many awards and honors include first prize at the Nikolai Rubinstein International Competition in France as well as

to oppose criminal charges. He added that based on the arresting officer's statement, he was satisfied that probable cause has been met for the case to proceed. Adding that Lanigan has "no appreciable criminal record" and a low risk of re-offense, the judge set the cash bail at \$3,000. He also ruled that Lanigan cannot use or possess dangerous weapons and can have no contact of any kind with the victim.

The charges stemmed from an incident on the afternoon of Friday, Oct. 25. According to the

complaint filed by Sanford Police Sgt. Jeremy Riddle, the victim confronted Lanigan after finding him with another woman at Springvale Safe Storage on River Street. The complaint alleges that Lanigan choked the victim for approximately 20 seconds before she got away and called friends, who contacted police.

Sgt. Riddle noted that the victim had bruising on both sides of her neck as well as petechiae on her face, nose, and inside her mouth. Petechiae are small red spots caused by broken blood vessels, which are often present in cases of strangulation. Lanigan's attorney argued that the petechiae were caused by severe vomiting due to the victim taking Antabuse, a drug prescribed to deter alcohol use that causes vomiting and other side effects when alcohol is ingested.

The victim confirmed that she is in recovery and had been sober for 30 days prior to this incident.

Lanigan, a Republican, represents District 141 in the State Legislature, which includes parts of Sanford and Springvale as well as the towns of Shapleigh and Newfield. Reaction to the charges from House leadership has fallen along partisan lines, with Democrats calling for his immediate resignation and Republicans saying that was premature until he has had his day in court.

Lanigan is up for re-election on Tuesday. He is being challenged by Democrat Patricia Kidder of Springvale. According to a State House source who requested anonymity, if Lanigan wins re-election but later resigns or is removed, the seat would be filled by a special election.

No trial date has been set. A dispositional conference is scheduled for March 5, 2025, at which time the prosecution and defense will meet with the judge to discuss the merits of the evidence, the defense and any pretrial motions.

Survey Says: Don't Ban Cell Phones Now

Sanford schools will keep their current cell phone policy for now following a review of survey responses on the subject by the School Committee at an Oct. 21 workshop. Students, parents and staff members see cell phones differently according to the survey, but there is consensus that a complete ban is not necessary.

The policy now requires cell phones to be on silent and in a designated area to avoid disruptions during class. It also restricts their use during school hours to hall passing time, lunch, the bus, or any other time where it may be beneficial to use them. Committee members decided to continue mon-

itoring enforcement efforts, which didn't really

start until this school year.

The survey collected responses from about 1,500 students in the middle and high schools. The results were very supportive of the use of cellphones during school hours. Some students believed additional restrictions would be beneficial, but they were in the minority. The parent survey received about 970 responses. While most parents agree that students should be able to use their phones during school hours, many believe that there should be restrictions and that phones may have a negative influence on the students' time in school. Some parents also said their children should have access to cell phones in case of emergencies.

About 180 staff members also responded. Many said they feel that cell phones have a negative impact on the learning environment and that more restrictions need to be considered. Though most staff respondents believe that there are negative impacts of cell phone use during school, only about half favored banning them entirely. Many felt that despite the negatives of cell phones in school, they can have academic benefits.

Some on the committee said they were concerned about the survey itself. For instance, students and staff gave conflicting estimates of how much time students spend on phones and how distracting they are. Also, some questioned the decision to combine the results of the middle and high responses instead of looking at each separately. Separate surveys for middle and high school students are possible in the future.



OUT IN THE WOODS

Tree Burls a Bit of a Mystery

Burls can be found on many tree species, but most often on oaks, maples, and cherries. Many woodworkers and woodturners are interested in the unusual grain patterns and colors found in burlwood. But what causes them to grow at all?

According to Kevin Smith, supervisory plant physiologist with the U.S. Forest Service, "A burl is the result of hyperplasia, a greatly abnormal proliferation of xylem production by the vascular cambium." In other words, an area of a tree produces a wildly random growth pattern that's initiated by hormonal changes.

What causes the hormonal changes? A theory for burl formation and growth is that it could be the tree's protective reaction to an invasion of a bacteria, virus, or fungus, possibly initiated by insect attack. An insect causes a tiny injury in the tree while looking for food, sap, or an egg-laying spot, which opens a tiny wound that allows the virus or fungus entry. And sometimes burls form around an area of branch removal or damage. So, the tree may try to isolate the viral or fungal invasion by surrounding it with woody growth — the same process that oak trees

use when they make those grape-like oak galls we see on our trail walks. Since the invasion doesn't necessarily follow circular or straight lines of attack, the woody protective growth tends to be erratic as the tree's growth follows the invasion. The burl grows, forming beautifully figured grain patterns that woodworkers love for their bowl turnings and clock faces.

If burl formation were better understood, commercial production would be possible to form a reliable source for marketing artisanal woodworking burls. A challenge to the market would be that the final appearance of the grain figuring is highly unpredictable, known only after a burl is cut into workable pieces. Another is that the twisting and turning grain patterns typically result in a weakness in structure, so the finished product would need to be a "form-over-function" product, unable to withstand common stresses that normal wood can.

Burls don't seem to cause fatal damage to the tree, or even hurt it at all. But the random growth nature of the burl could cause an area of weakness, or even allow further invasive attacks by other pathogens. Foresters seem to be in general agreement that, for the overall health of the tree, it's best to simply let the burl grow. Removing a large burl causes a wound that would offer entry to a host of pathogens and insects that could result in decay and tree death; Healing from such a wound would be extremely difficult.

So enjoy burls where you happen upon them, growing happily in their habitat and giving us trail walkers yet another opportunity to stop and ponder nature's wonders and mysteries!



and reached new heights this year," said SHS Music Director Hailey Francoeur.



Per their permit, GVS is required to report any accidental discharge within 24 hours. We were not made aware of these discharges until over ten (10) months later. This constitutes another event of significant non-compliance.

Northeast Coating Technologies: Like all permitted industrial users, this company is required to submit two annual monitoring reports per year. At the time of this writing, their second report has still not been submitted. At this point, the report is over one hundred and six (106) days late. Additionally, this company has had exceedances of nickel and aluminum, well over local limits, in their wastewater analysis. Both violations constitute significant non-compliance.


